Textual Information(1)	<p>The Hon'ble National Company Law Tribunal, Ahmedabad Bench vide its order dated 11th July, 2024 approved the resolution plan for revival of Asya Infosoft Limited (The Company). The said order came in to effect from 11th July, 2024. The Company has carried out capital restructuring as per the approved Resolution Plan and consequently the authorised capital of the Company has been increased to Rs. 50,00,00,000 and the updated paid-up share capital is 47,26,02,800. According to Rule 19 A of the Securities Contracts (Regulation) Rules a listed entity shall have at least 25 per cent of public shareholding but post the acquisition of the Company the minimum public shareholding requirements are not met by the Company. Further as per the relaxation provided in case of acquisition of listed company under Corporate Insolvency Resolution Process, if the public shareholding falls below 10% then the same shall be increased to 10% within 12 months from the date of such shortfall. It is hereby stated that the Promoters shall dilute the shares to a minimum of 25% within three years as per the requirement of applicable regulations. The Company is actively pursuing initiatives to increase public shareholding to the required level as per the provisions of the Securities and Exchange Board of India in compliance with the applicable norms.</p>
