The Notice of the 41st AGM along with the integrated Annual Report of the Company for the financial year 2025-26 will be sent only by email to all those Members, whose email addresses are registered with the Company Registrar and Share Transfer Agent (RTA) or with their respective Depository Participants, in accordance with the MCA Circulars and the SEBI Circulars. A Letter providing the web-link of the Integrated Annual Report will be sent to those Shareholders whose email addresses are not registered. The Company shall send a physical copy of the AGM Notice and Integrated Annual Report to those members who request for the same at cs@axisindia.in mentioning their Folio No./ DP ID & Client ID. Members who have not registered their e-mail addresses with the Depositories/ Company RTA are requested to register/update their e-mail addresses in the following manner:

The Board of Directors of the Company at its meeting held on 21st May, 2026 recommended Final Dividend of Rs. 0.60 per equity share of face value of Rs. 10 each fully paid up (6%), subject to the approval of members at ensuing AGM of the Company for FY 2025-26.

The Company has fixed Saturday, 12th September, 2026 as the Record Date for determining entitlement of members to Final Dividend for the financial year ended on 31st March, 2026, if approved at the AGM. The dividend will be paid through permitted mode on or before Monday, 19th October, 2026, if declared at the AGM.
